Plaintiff, the Federal Trade Commission (“Commission”), filed its Complaint for Permanent Injunction and Other Equitable Relief in this matter, pursuant to Section 13(b) of the Federal Trade Commission Act (“FTC Act”), 15 U.S.C. § 53(b). The Commission and Defendants stipulate to entry of this Stipulated Order for Permanent Injunction and Monetary Judgment (“Order”) to resolve all matters in dispute in this action between them.

THEREFORE, IT IS ORDERED as follows:

**FINDINGS**

1. This Court has jurisdiction over this matter.
2. The Complaint charges that Defendants participated in deceptive acts or practices in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52, in connection with the advertising, marketing, distribution, offering for sale, and sale of ultraviolet light disinfection devices, including the Nano-UV

1 Disinfection Scanner, the Nano-UV Wand, and the Nano-UV Water Disinfectant  
2 devices.

3 3. Defendants neither admit nor deny any of the allegations in the  
4 Complaint, except as specifically stated in this Order. Only for purposes of this  
5 action, Defendants admit the facts necessary to establish jurisdiction.  
6

7 4. Defendants waive any claim they may have under the Equal Access to  
8 Justice Act, 28 U.S.C. § 2412, concerning the prosecution of this action through the  
9 date of this Order, and agree to bear their own costs and attorney fees.  
10

11 5. Defendants and the Commission waive all rights to appeal or otherwise  
12 challenge or contest the validity of this Order.  
13

#### 14 **DEFINITIONS**

15 For the purpose of this Order, the following definitions apply:  
16

17 A. “Defendants” means all the Individual Defendants and the Corporate  
18 Defendant, individually, collectively, or in any combination.  
19

20 B. “Corporate Defendant” means Defendant Zadro Health Solutions, Inc.,  
21 and its successors and assigns.  
22

23 C. “Individual Defendants” means Zlatko Zadro and Rebecca Zadro, aka  
24 Becky Zadro.  
25

26 D. “Device,” as defined in Section 15 of the FTC Act, 15 U.S.C. § 55,  
27 means an instrument, apparatus, implement, machine, contrivance, implant, in vitro  
28

1 reagent, or other similar or related article, including any component, part, or  
2 accessory, which is (1) recognized in the official National Formulary, or the United  
3 States Pharmacopeia, or any supplement to them; (2) intended for use in the  
4 diagnosis of disease or other conditions, or in the cure, mitigation, treatment, or  
5 prevention of disease, in man or other animals; or (3) intended to affect the structure  
6 or any function of the body of man or other animals; and which does not achieve  
7 any of its principal intended purposes through chemical action within or on the  
8 body of man or other animals and which is not dependent upon being metabolized  
9 for the achievement of any of its principal intended purposes.  
10  
11  
12

13 E. “Reliably Reported,” for a human clinical test or study (“test”), means  
14 a report of the test has been published in a peer-reviewed journal, and such  
15 published report provides sufficient information about the test for experts in the  
16 relevant field to assess the reliability of the results.

19 **ORDER**

20 **I.**

21 **PROHIBITION AGAINST FALSE OR UNSUBSTANTIATED CLAIMS**

22 IT IS ORDERED that Defendants, Defendants’ officers, agents, and  
23 employees, and all other persons in active concert or participation with any of them,  
24 who receive actual notice of this Order, whether acting directly or indirectly,  
25  
26  
27  
28

1 are permanently restrained and enjoined from making, or assisting others in making,

2 A. any misrepresentation, expressly or by implication, in connection with  
3 the promoting or offering for sale of any Device, that:  
4

- 5 1. the Device kills 99.9%, or any percentage, of bacteria, germs,  
6 and viruses, including *E. coli*, *Salmonella*, *Staphylococcus*  
7 *Aureus*, and the H1N1 virus, on any surface in only 10 seconds  
8 or any time period;
- 9 2. the Device stops the spread of germs, from the common cold  
10 and flu viruses to bacteria, mold, and fungus;
- 11 3. the Device kills dust mite populations and eggs, flea eggs, and  
12 bed bug eggs in pillows, bedding, and carpet; or
- 13 4. the Device eliminates 99.9%, or any percentage, of bacteria,  
14 mold, and fungus on water surfaces in only 10 seconds or any  
15 time period, or in water in only 40 seconds or any time period;  
16  
17 and  
18  
19  
20  
21

22 B. any representation, expressly or by implication, about the health  
23 benefits, performance, or efficacy of any product or service, unless the  
24 representation is non-misleading, and, at the time such representation is made,  
25 Defendants possess and rely upon competent and reliable scientific evidence that is  
26 sufficient in quality and quantity based on standards generally accepted in the  
27  
28

1 relevant scientific fields, when considered in light of the entire body of relevant and  
2 reliable scientific evidence, to substantiate that the representation is true.

3 For purposes of this Section, competent and reliable scientific evidence  
4 means tests, analyses, research, or studies (1) that have been conducted and  
5 evaluated in an objective manner by qualified persons; (2) that are generally  
6 accepted in the profession to yield accurate and reliable results; and (3) as to which,  
7 when they are human clinical tests or studies, all underlying or supporting data and  
8 documents generally accepted by experts in the field as relevant to an assessment of  
9 such testing as set forth in the Section entitled Preservation of Records Relating to  
10 Competent and Reliable Human Clinical Tests or Studies are available for  
11 inspection and production to the Commission.  
12  
13  
14  
15

16 **II.**

17 **PROHIBITED REPRESENTATIONS REGARDING TESTS OR STUDIES**

18  
19 IT IS FURTHER ORDERED that Defendants, Defendants' officers, agents,  
20 and employees, and all other persons in active concert or participation with any of  
21 them, who receive actual notice of this Order, whether acting directly or indirectly,  
22 in connection with the promoting or offering for sale of any product or service, are  
23 permanently restrained and enjoined from misrepresenting or assisting others in  
24 misrepresenting, in any manner, expressly or by implication:  
25  
26  
27  
28

1 A. That the benefits of such product or service are scientifically proven;

2 or

3 B. The existence, contents, validity, results, conclusions, or interpretations  
4 of any test, study, or research.  
5

6 **III.**

7  
8 **PRESERVATION OF RECORDS RELATING TO COMPETENT AND**  
9 **RELIABLE HUMAN CLINICAL TESTS OR STUDIES**

10 IT IS FURTHER ORDERED that, with regard to any human clinical test or  
11 study (“test”) upon which Defendants rely to substantiate any claim covered by this  
12 Order, Defendants shall secure and preserve all underlying or supporting data and  
13 documents generally accepted by experts in the field as relevant to an assessment of  
14 the test, including, but not necessarily limited to:  
15  
16

17 A. All protocols and protocol amendments, reports, articles, write-ups, or  
18 other accounts of the results of the test, and drafts of such documents reviewed by  
19 the test sponsor or any other person not employed by the research entity;  
20

21 B. All documents referring or relating to recruitment; randomization;  
22 instructions, including oral instructions, to participants; and participant compliance;  
23

24 C. Documents sufficient to identify all test participants, including any  
25 participants who did not complete the test, and all communications with any  
26 participants relating to the test; all raw data collected from participants enrolled in  
27  
28

1 the test, including any participants who did not complete the test; source documents  
2 for such data; any data dictionaries; and any case report forms;

3 D. All documents referring or relating to any statistical analysis of any test  
4 data, including, but not limited to, any pretest analysis, intent-to-treat analysis, or  
5 between-group analysis performed on any test data; and  
6

7 E. All documents referring or relating to the sponsorship of the test,  
8 including all communications and contracts between any sponsor and the test's  
9 researchers.  
10

11  
12 Provided, however, the preceding preservation requirement shall not apply to  
13 a Reliably Reported test, unless the test was conducted, controlled, or sponsored, in  
14 whole or in part by: (1) any Defendant; (2) any Defendant's officers, agents,  
15 representatives, or employees; (3) any other person or entity in active concert or  
16 participation with any Defendant; (4) any person or entity affiliated with or acting  
17 on behalf of any Defendant; (5) any supplier of any ingredient contained in the  
18 product at issue to any of the foregoing or to the product's manufacturer; or (6) the  
19 supplier or manufacturer of such product.  
20  
21

22  
23 For any test conducted, controlled, or sponsored, in whole or in part, by  
24 Defendants, Defendants must establish and maintain reasonable procedures to  
25 protect the confidentiality, security, and integrity of any personal information  
26 collected from or about participants. These procedures shall be documented in  
27  
28



1 writing and shall contain administrative, technical, and physical safeguards  
2 appropriate to Defendants' size and complexity, the nature and scope of  
3 Defendants' activities, and the sensitivity of the personal information collected from  
4 or about the participants.  
5

6 **IV.**

7 **FDA APPROVED CLAIMS**

8  
9 IT IS FURTHER ORDERED that nothing in this Order shall prohibit  
10 Defendants from:

11  
12 A. Making any representation for any drug that is permitted in labeling for  
13 such drug under any tentative or final monograph promulgated by the Food and  
14 Drug Administration, or under any new drug application approved by the Food and  
15 Drug Administration; and  
16

17  
18 B. Making any representation for any product that is specifically  
19 permitted in labeling for such product by regulations promulgated by the Food and  
20 Drug Administration pursuant to the Nutrition Labeling and Education Act of 1990  
21 or permitted under Sections 303-304 of the Food and Drug Administration  
22 Modernization Act of 1997.  
23

V.

**MONETARY JUDGMENT**

IT IS FURTHER ORDERED that:

A. Judgment in the amount of Six Hundred Twenty-Nine Thousand Three Hundred and Fifty-Nine Dollars (\$629,359) is entered in favor of the Commission against Corporate Defendant Zadro Health Solutions, Inc., as equitable monetary relief.

B. Corporate Defendant Zadro Health Solutions, Inc. is ordered to pay to the Commission Two Hundred Twenty-Two Thousand and Twenty-Nine Dollars (\$222,029), which, as Defendants stipulate, their undersigned counsel holds in escrow for no purpose other than payment to the Commission. Such payment must be made within 7 days of entry of the Order by electronic fund transfer in accordance with instructions to be provided by a representative of the Commission. Upon such payment, the remainder of the judgment is suspended, subject to the Subsections below.

C. The Commission's agreement to the suspension of the judgment is expressly premised upon the truthfulness, accuracy, and completeness of Defendant Zadro Health Solutions, Inc.'s sworn financial statements and related documents (collectively, "financial representations") submitted to the Commission, namely the Financial Statement of Corporate Defendant Zadro Health Solutions, Inc., signed by

1 corporate president Zlatko Zadro on June 15, 2015, including the attachments.

2 D. The suspension of the judgment will be lifted if, upon motion by the  
3 Commission, the Court finds that Defendant Zadro Health Solutions, Inc. failed to  
4 disclose any material asset, materially misstated the value of any asset, or made any  
5 other material misstatement or omission in the financial representations identified  
6 above.  
7

8  
9 E. If the suspension of the judgment is lifted, the judgment becomes  
10 immediately due as to Defendant Zadro Health Solutions, Inc. in the amount  
11 specified in Subsection A. above, which the parties stipulate only for purposes of  
12 this Section represents the consumer injury alleged in the Complaint, less any  
13 payment previously made pursuant to this Section, plus interest computed from the  
14 date of entry of this Order.  
15  
16

17 F. Defendants relinquish dominion and all legal and equitable right, title,  
18 and interest in all assets transferred pursuant to this Order and may not seek the  
19 return of any assets.  
20

21 G. The facts alleged in the Complaint will be taken as true, without  
22 further proof, in any subsequent civil litigation or proceeding by or on behalf of the  
23 Commission to enforce its rights to any payment or monetary judgment pursuant to  
24 this Order, such as a nondischargeability complaint in any bankruptcy case.  
25  
26  
27  
28

1           H.     The facts alleged in the Complaint establish all elements  
2 necessary to sustain an action by the Commission pursuant to Section 523(a)(2)(A)  
3 of the Bankruptcy Code, 11 U.S.C. § 523(a)(2)(A), and this Order will have  
4 collateral estoppel effect for such purposes.  
5

6           I.     Defendant Zadro Health Solutions, Inc. acknowledges that its  
7 Taxpayer Identification Number (Employer Identification Number), which  
8 Defendant previously submitted to the Commission, may be used for collecting and  
9 reporting on any delinquent amount arising out of this Order, in accordance with 31  
10 U.S.C. §7701.  
11

12           J.     All money paid to the Commission pursuant to this Order may be  
13 deposited into a fund administered by the Commission or its designee to be used for  
14 equitable relief, including consumer redress and any attendant expenses for the  
15 administration of any redress fund. If a representative of the Commission decides  
16 that direct redress to consumers is wholly or partially impracticable or money  
17 remains after redress is completed, the Commission may apply any remaining  
18 money for such other equitable relief (including consumer information remedies) as  
19 it determines to be reasonably related to the practices alleged in the Complaint.  
20 Any money not used for such equitable relief is to be deposited to the U.S. Treasury  
21 as disgorgement. Defendants have no right to challenge any actions the  
22 Commission or its representatives may take pursuant to this Subsection.  
23  
24  
25  
26  
27

1 **VI.**

2 **CUSTOMER INFORMATION**

3 IT IS FURTHER ORDERED that Defendants, Defendants' officers, agents,  
4 and employees, and all other persons in active concert or participation with any of  
5 them, who receive actual notice of this Order, are permanently restrained and  
6 enjoined from directly or indirectly failing to provide sufficient customer  
7 information to enable the Commission to efficiently administer consumer redress.  
8

9 If a representative of the Commission requests in writing any information related to  
10 redress, Defendants must provide it, in the form prescribed by the Commission,  
11 within 14 days.  
12  
13

14 **VII.**

15 **COOPERATION**

16 IT IS FURTHER ORDERED that Defendants must fully cooperate with  
17 representatives of the Commission in this case and in any investigation related to or  
18 associated with the transactions or the occurrences that are the subject of the  
19 Complaint. Defendants must provide truthful and complete information, evidence,  
20 and testimony. Individual Defendants must appear and Corporate Defendant must  
21 cause its officers, employees, representatives, or agents to appear for interviews,  
22 discovery, hearings, trials, and any other proceedings that a Commission  
23 representative may reasonably request upon 5 days written notice, or other  
24  
25  
26  
27  
28

1 reasonable notice, at such places and times as a Commission representative may  
2 designate, without the service of a subpoena.

3  
4 **VIII.**

5 **ORDER ACKNOWLEDGMENTS**

6 IT IS FURTHER ORDERED that Defendants obtain acknowledgments of  
7 receipt of this Order:  
8

9 A. Each Defendant, within 7 days of entry of this Order, must submit to  
10 the Commission an acknowledgment of receipt of this Order sworn under penalty of  
11 perjury.  
12

13 B. For 5 years after entry of this Order, each Individual Defendant for any  
14 business such Defendant, individually or collectively with any other Defendants, is  
15 the majority owner or controls directly or indirectly, and the Corporate Defendant,  
16 must deliver a copy of this Order to: (1) all principals, officers, directors, and LLC  
17 managers and members; (2) all employees, agents, and representatives who  
18 participate in approving the advertising, marketing, distribution, offering for sale,  
19 and sale of such Defendant's products; and (3) any business entity resulting from  
20 any change in structure as set forth in the Section titled Compliance Reporting.  
21  
22

23 Delivery must occur within 7 days of entry of this Order for current personnel. For  
24 all others, delivery must occur before they assume their responsibilities.  
25  
26  
27  
28

1 C. From each individual or entity to which a Defendant delivered a copy  
2 of this Order, that Defendant must obtain, within 30 days, a signed and dated  
3 acknowledgment of receipt of this Order.  
4

5 **IX.**

6 **COMPLIANCE REPORTING**

7  
8 IT IS FURTHER ORDERED that Defendants make timely submissions to  
9 the Commission:

10 A. One year after entry of this Order, each Defendant must submit a  
11 compliance report, sworn under penalty of perjury.  
12

13 1. Each Defendant must: (a) identify the primary physical, postal,  
14 and email address and telephone number, as designated points of contact,  
15 which representatives of the Commission may use to communicate with  
16 Defendant; (b) identify all of that Defendant's businesses by all of their  
17 names, telephone numbers, and physical, postal, email, and Internet  
18 addresses; (c) describe the activities of each business, including the goods  
19 and services offered, the means of advertising, marketing, and sales, and the  
20 involvement of any other Defendant (which Individual Defendants must  
21 describe if they know or should know due to their own involvement);  
22 (d) describe in detail whether and how that Defendant is in compliance with  
23 each Section of this Order; and (e) provide a copy of each Order  
24  
25  
26  
27  
28

1 Acknowledgment obtained pursuant to this Order, unless previously  
2 submitted to the Commission.

3 2. Additionally, each Individual Defendant must: (a) identify all  
4 telephone numbers and all physical, postal, email and Internet addresses,  
5 including all residences; (b) identify all business activities, including any  
6 business for which such Defendant performs services whether as an  
7 employee or otherwise and any entity in which such Defendant has any  
8 ownership interest; and (c) describe in detail such Defendants' involvement  
9 in each such business, including title, role, responsibilities, participation,  
10 authority, control, and any ownership.  
11  
12  
13  
14

15 B. For 10 years after entry of this Order, each Defendant must submit a  
16 compliance notice, sworn under penalty of perjury, within 14 days of any change in  
17 the following:  
18

19 1. Each Defendant must report any change in: (a) any designated  
20 point of contact; or (b) the structure of the Corporate Defendant or any entity  
21 such Defendant has any ownership interest in or controls directly or  
22 indirectly that may affect compliance obligations arising under this Order,  
23 including: creation, merger, sale, or dissolution of the entity or any  
24 subsidiary, parent, or affiliate that engages in any acts or practices subject to  
25 this Order.  
26  
27  
28



1           2.       Additionally, each Individual Defendant must report any change  
2       in: (a) name, including aliases or fictitious names, or residence address; or (b)  
3       title or role in any business activity, including any business for which such  
4       Defendant performs services whether as an employee or otherwise and any  
5       entity in which such Defendant has direct or indirect control, and identify the  
6       name, physical address, and any Internet address of the business or entity.  
7  
8

9           C.       Each Defendant must submit to the Commission notice of the filing of  
10       any bankruptcy petition, insolvency proceeding, or similar proceeding by or against  
11       the Defendant within 14 days of its filing.  
12

13           D.       Any submission to the Commission required by this Order to be sworn  
14       under penalty of perjury must be true and accurate and comply with 28 U.S.C. §  
15       1746, such as by concluding: “I declare under penalty of perjury under the laws of  
16       the United States of America that the foregoing is true and correct. Executed on:  
17       \_\_\_\_\_” and supplying the date, signatory’s full name, title (if applicable), and  
18       signature.  
19

22           E.       Unless otherwise directed by a Commission representative in writing,  
23       all submissions to the Commission pursuant to this Order must be emailed to

5 **RECORDKEEPING**

6 IT IS FURTHER ORDERED that Defendants must create certain records for  
7  
8 10 years after entry of the Order, and retain each such record for 5 years.

9 Specifically, Corporate Defendant and each Individual Defendant for any business  
10 that such Defendant, individually or collectively with any other Defendants, is a  
11 majority owner or controls directly or indirectly, must create and retain the  
12 following records:  
13

14 A. Accounting records showing the revenues from all goods or services  
15 sold;  
16

17 B. Personnel records showing, for each person providing services,  
18 whether as an employee or otherwise, that person's: name, addresses, telephone  
19 numbers, job title or position, dates of service, and (if applicable) the reason for  
20 termination;  
21

22 C. Records of all consumer complaints and refund requests, whether  
23 received directly or indirectly, such as through a third party, and any response;  
24

25 D. All records necessary to demonstrate full compliance with each  
26 provision of this Order, including all submissions to the Commission; and  
27  
28

1 E. A copy of each unique advertisement or other marketing material.

2 **XI.**

3 **COMPLIANCE MONITORING**

4  
5 IT IS FURTHER ORDERED that, for the purpose of monitoring Defendants'  
6 compliance with this Order, and any failure to transfer any assets as required by this  
7 Order:  
8

9 A. Within 14 days of receipt of a written request from a representative of  
10 the Commission, each Defendant must: submit additional compliance reports or  
11 other requested information, which must be sworn under penalty of perjury; appear  
12 for depositions; and produce documents for inspection and copying. The  
13 Commission is also authorized to obtain discovery, without further leave of court,  
14 using any of the procedures prescribed by Federal Rules of Civil Procedure 29, 30  
15 (including telephonic depositions), 31, 33, 34, 36, 45, and 69.  
16  
17  
18

19 B. For matters concerning this Order, the Commission is authorized to  
20 communicate directly with each Defendant. Each Defendant must permit  
21 representatives of the Commission to interview any employee or other person  
22 affiliated with the Defendant who has agreed to such an interview. The person  
23 interviewed may have counsel present.  
24  
25

26 C. The Commission may use all other lawful means, including posing,  
27 through its representatives, as consumers, suppliers, or other individuals or entities,  
28

1 to Defendants or any individual or entity affiliated with Defendants, without the  
2 necessity of identification or prior notice. Nothing in this Order limits the  
3 Commission's lawful use of compulsory process, pursuant to Sections 9 and 20 of  
4 the FTC Act, 15 U.S.C. §§49, 57b-1.

5  
6 D. Upon written request from a representative of the Commission, any  
7 consumer reporting agency must furnish consumer reports concerning Individual  
8 Defendants pursuant to Section 604(1) of the Fair Credit Reporting Act, 15 U.S.C.  
9 §1681b(a)(1).  
10  
11

12 **XII.**

13 **RETENTION OF JURISDICTION**

14  
15 IT IS FURTHER ORDERED that this Court retains jurisdiction of this matter  
16 for purposes of construction, modification, and enforcement of this Order.  
17  
18
