## FIRST JOINT STATUS REPORT

Pursuant to the Scheduling Order entered by the Court on December 4, 2006, Complaint Counsel and Respondent Realcomp II Ltd. respectfully submit this First Joint Status Report.

### I. <u>STATUS OF DISCOVERY</u>

The parties are conducting fact discovery expeditiously. Complaint Counsel has served three Requests for the Production of Documents and Things, two Sets of Interrogatories, and one Request for Admissions on Respondent.
