TIME TO ANSWER ADMINISTRATIVE COMPLAINT**


Pursuant to Rules 3.22 and 4.3(b) of the Rules of Practice of the Federal Trade Commission, 16 C.F.R. §§ 3.22, 4.3(b), all Respondents respectfully move for an Order extending Respondents' time to answer the Administrative Complaint issued in the above-captioned matter. In support of their motion, Respondents state as follows:

1. Pursuant to Rule 3.12(a) of the Federal Trade Commission Rules of Practice, 16 C.F.R. § 3.12(a), Respondents' deadline to answer the Administrative Complaint is presently May 9, 2011.

2. Certain of Respondents' counsel have recently been retained as counsel in this matter and request a limited extension of five (5) business days to respond to the Administrative Complaint.
3. Respondents have informed Complaint Counsel of their request for a limited extension, and Complaint Counsel have stated that they do not oppose a five-day extension of Respondents' deadline to answer. The parties do not intend for this limited extension to affect the scheduled hearing date or the discovery and related deadlines leading up the hearing.

Respondents therefore respectfully request that the Administrative Law Judge enter an order extending Respondents' deadline to answer the Administrative Complaint until May 16, 2011. A proposed order is attached hereto for the convenience of the Administrative Law Judge.


