## **REVISED SCHEDULING ORDER**

The Scheduling Order in this case was originally issued on May 31, 2011 and revised on July 5, 2011. By Order dated July 15, 2011, the Commission stayed these proceedings. By Order dated March 14, 2013, the Commission lifted the Stay and directed the issuance of revised scheduling deadlines, including a new hearing to begin no later than July 15, 2013.

On March 19, 2013, Respondents filed with the Commission a Motion to Reschedule Hearing Date, which Complaint Counsel opposed on March 21, 2013. By Order dated April 3, 2013, the Commission denied Respondents' Motion but, as a matter of discretion, granted a three-week extension of the hearing date and directed that the hearing be set no later than August 5, 2013.

Accordingly, the dates in the May 31, 2011 Scheduling Order, as revised by the July 5, 2011 Revised Scheduling Order, are revised as set forth below. All additional provisions in the May 31, 2011 Scheduling Order are unchanged.

		The parties are to meet and confer prior to the conference regarding trial logistics and proposed stipulations of law, facts, and authenticity of exhibits and any designated deposition testimony. To the extent the parties stipulate to certain issues, the parties shall prepare a Joint Exhibit which lists the agreed stipulations.
		Counsel may present any objections to the final proposed witness lists and exhibits. Trial exhibits will be admitted or excluded to the extent practicable. To the extent the parties agree to the admission of each other's exhibits, the parties shall prepare a Joint Exhibit which lists the exhibits to which neither side objects. Any Joint Exhibit will be signed by each party with no signature for the judge required.
