## ORDER ON MOTIONS OF NONPARTIES TO QUASH OR LIMIT SUBPOENAS *DUCES TECUM*

On May 6, 2013, Barrow Regional Medical Center, Clearview Regional Medical Center, East Georgia Regional Medical Center, Miller County Hospital, and St. Francis Hospital each filed a motion to quash or limit subpoenas *duces tecum* served upon them by Respondents. On May 7, 2013, Appling County Healthcare System, The Cobb Foundation, Inc., Effingham Hospital, and Ty Cobb Healthcare System, Inc. each filed a motion to quash or limit subpoenas *duces tecum* served upon them by Respondents. On May 8, 2013, Jack Hughston Memorial Hospital filed a motion to quash or limit subpoenas *duces tecum* served upon it by Respondents. On May 10, 2013, AMGP Georgia Managed Care Company, Inc., DeKalb Medical Center, Inc., Northside Hospital, Inc., and Peach State Health Plan each filed a motion to quash or limit subpoenas *duces tecum* served upon them by Respondents. On May 13, 2013, Jackson Hospital and Mayo Clinic Health System each filed a motion to quash or limit subpoenas *duces tecum* served upon them by Respondents. Collectively, these motions are referred to as the "Motions of Nonparties to Quash or Limit Subpoenas *Duces Tecum*."

Pursuant to Commission Rule 3.22(d), within 10 days after service of any written motion, the opposing party shall answer or shall be deemed to have consented to the granting of the relief asked for in the motion. Respondents have filed no oppositions to the Motions of Nonparties to

Quash or Limit Subpoenas *Duces Tecum*. Instead, Respondents informed the Office of Administrative Law Judges that the Motions of Nonparties to Quash or Limit Subpoenas *Duces Tecum* have either been settled subsequent to the filing of each motion, or Phoebe Putney is no longer seeking to enforce these subpoenas.

Because Respondents are no longer pursuing any action on these subpoenas, the Motions of Nonparties to Quash or Limit Subpoenas *Duces Tecum* are DENIED AS MOOT WITHOUT PREJUDICE.
