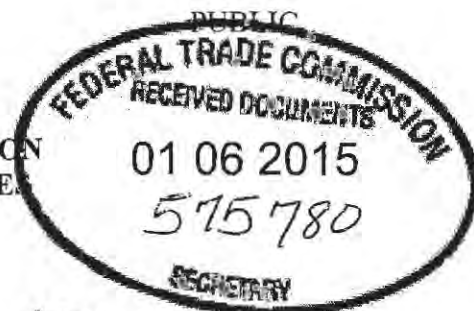

**JOINT MOTION TO EXTEND PRETRIAL DEADLINES AND REVISE THE  
SCHEDULING ORDER**

Pursuant to Commission Rule of Practice 3.21(c)(2), the parties respectfully request that the Court issue a revised scheduling order extending certain pretrial deadlines. 16 C.F.R. §3.21(c)(2). On December 22, 2014, the Commission rescheduled the hearing in this matter to March 23, 2015 and stated that “the Administrative Law Judge may issue a revised scheduling order to account for the rescheduled hearing date.”<sup>1</sup>

In light of the new hearing date and the Commission’s order, the parties request that the Court issue a revised scheduling order with the following deadlines:

- January 13, 2015 – Respondent Jerk, LLC responds to Complaint Counsel’s interrogatories and document requests as required by the Court’s August 15, 2014 and November 25, 2014 orders
- Between January 27 and January 30, 2015 – Respondent Jerk, LLC produces qualified individual(s) to testify as to matters known or reasonably available to Jerk in response to

Complaint Counsel's 3.33(c)(1) deposition notice, as required by the Court's August 15, 2014 Order

- March 5, 2015 – Deadline for filing motions *in limine* to preclude admission of evidence
- March 6, 2015 – Complaint Counsel file pretrial brief
- March 9, 2015 – Parties exchange and serve courtesy copy on ALJ of objections to final proposed witness lists and exhibit lists
- March 10, 2015 – Parties exchange stipulations of law, facts, and authenticity
- March 13, 2015 – Respondents file pretrial brief
- March 16, 2015 – Parties file final stipulations of law, facts, and authenticity
- March 17, 2015 – Final pretrial conference
- March 23, 2015 – Commencement of Hearing
