

Respondents and the individual third parties would incur in filing individual motions seeking *in camera* treatment for their exhibits. As it stands, Complaint Counsel and Respondents expect to notify approximately 125 non-parties regarding the procedure for seeking *in camera* treatment by June 19.

Therefore, Complaint Counsel and respondents respectfully request an order amending the deadlines for (1) providing notices to parties and non-parties of an intent to offer confidential materials at the hearing, now set for June 19, 2015, to June 29, 2015; (2) filing motions for *in camera* treatment of proposed trial exhibits, now set for June 29, 2015, to July 9, 2015; and (3) responding to any *in camera* motions that are filed, now set for July 6, 2015, to July 12, 2015.

A proposed order is attached.
