NON-PARTY UTILITY ASSOCIATES, INC. UNOPPOSED MOTION FOR AN EXTENSION OF TIME FOR TO FILE MOTION FOR *IN CAMERA* TREATMENT

Pursuant to Rule 3.21 of the Federal Trade Commission's (FTC) Rules of Practice and 16 CFR § 3.45(b), non-party Utility Associates, Inc. ("Utility") respectfully moves this Court for a two-day extension of the September 23, 2020 deadline to file a Motion for *in Camera* Treatment., to September 25, 2020. The FTC and Respondent Axon Enterprises Inc. ("Axon") do not oppose Utility's motion.

1. On September 11, 2020, FTC Complaint Counsel provided notice by email to Utility that it intended to designate for possible use at trial certain documents and the complete deposition testimony of a Utility witness produced by Utility pursuant to an "Outside-Counsel Only" confidentiality designation. Late in the evening on September 11, 2020, counsel for Axon provided similar notice, identifying the deposition and additional documents, as well as providing copies of the proposed exhibits, to Utility. On September 15, 2020, FTC Complaint Counsel provided copies of the materials it proposes to use.

- 2. Utility and its counsel are in the process of reviewing the designated materials and identifying those for which Utility will seek *in camera* treatment. However, some additional time is needed to complete the review process and prepare the requisite showing for any materials Utility identifies as requiring *in camera* treatment. Utility has not sought or obtained any other extensions of time in this proceeding.
- 3. Counsel for Utility has conferred with Complaint Counsel and Axon's counsel, and neither opposes this motion.

Therefore, Utility respectfully requests an extension of time to file a Motion for *in Camera* Treatment until September 25, 2020.
