<u>COMPLAINT COUNSEL'S MEMORANDUM IN OPPOSITION</u> TO RESPONDENTS' REQUEST FOR EXPEDITED CONSIDERATION

Respondents Illumina, Inc. ("Illumina") and GRAIL, Inc. ("GRAIL") (collectively, "Respondents") filed a Motion for Conference to Facilitate Settlement ("Motion") at midnight on July 2, 2021. Respondents' Proposed Order ("Order") would require both Respondents and Complaint Counsel to submit a "statement of its settlement position"¹ tomorrow, one business day after Respondents filed their Motion and without providing Complaint Counsel the opportunity to file any opposition to its underlying papers.

Further, before they filed the motion – and despite Complaint Counsel's request, Respondents refused to identify the settlement proposal that they wished to discuss and only provided it as exhibits to its Motion. Complaint Counsel intends to assess Respondents' proposal and to file its response to Respondents' Motion within ten days – i.e., by Thursday, July 15, 2021 – as provided for by Rule 3.22(d). Complaint Counsel respectfully asks this Court to deny Respondents' request to require the submission of settlement papers on July 7. Complaint

Counsel also requests that this Court deny Respondents' request for a settlement conference on July 8, 2021 and defer a decision as to when and whether to set a settlement conference until after Complaint Counsel has filed its response to Respondents' underlying motion.
