RESPONDENT GRAIL, LLC'S REPLY IN SUPPORT OF RESPONDENT GRAIL, LLC'S THIRD MOTION FOR IN CAMERA REVIEW OF CERTAIN TRIAL EXHIBITS

In accordance with the Court's Order, on August 27, 2021, the undersigned counsel for GRAIL, LLC filed its Third Motion For *In Camera* Review of Certain Trial Exhibits. ("Third Motion"). As described therein, the Third Motion eliminated over 200 documents from GRAIL's prior request for *in camera* treatment, and, on average, cut the length of time requested for *in camera* treatment nearly in half. *See* Third Motion at 1-2. Complaint Counsel filed its Opposition to the Third Motion on September 1, 2021 ("Third Opposition"). Therein, Complaint Counsel specifically objected to GRAIL's requested *in camera* treatment of portions of two transcripts of testimony from GRAIL's CEO Hans Bishop. Complaint Counsel's Third Opposition did not specifically identify any other exhibit or transcript for which it objected to GRAIL's requested relief for *in camera* treatment.

In an effort to facilitate the Court's resolution of GRAIL's Third Motion, GRAIL hereby agrees to de-designate the portions of the GRAIL-related materials that Complaint Counsel specifically identified in Sections II.B and II.C of its Third Opposition. Specifically, GRAIL de-

designates the following testimony from the investigatory hearing and deposition of Hans Bishop: PX7069 at 64:14-65:23, 82:22-83:12, 84:8-85:18, 94:13-95:4, 96:21-23, 98:17-20, 101:12-102:25, 103:18-104:5, 104:14-105:25, 106:1-107:1 (Hans Bishop Investigatory Hearing Transcript); PX7083 at 53:1-55:4, 69:2-71:19, 72:23-73:7, 79:2-3, 82:4-83:17, 84:13-87:10, 111:13-112:2, 116:7-118:8, 176:22-177:2 (Hans Bishop Deposition Transcript).

Through this de-designation, GRAIL has addressed the specific objections that Complaint Counsel raised in its Third Opposition as to GRAIL's Third Motion. Accordingly, GRAIL respectfully requests that the Court Grant the remainder of GRAIL's Third Motion.
