**NON-PARTY AT KEARNEY, INC.'S UNOPPOSED MOTION FOR AN
EXTENSION OF TIME TO FILE MOTION FOR *IN CAMERA* TREATMENT**

Pursuant to Rules 3.21 of the Federal Trade Commission's Rules of Practice ("Rules of Practice"), 16 C.F.R. §3.45(b), non-party AT Kearney, Inc. ("AT Kearney") respectfully moves this Court for a brief Extension of Time to File a Motion for in Camera Treatment. Both the Federal Trade Commission and Respondent have notified AT Kearney that they intend to introduce a total of 31 of AT Kearney's documents and the complete deposition testimony related thereto into evidence during the trial of this matter. Pursuant to the current scheduling order, motions for *in camera* treatment are due on June 11, 2018. While AT Kearney intends to file a Motion for in Camera Treatment for portions of this evidence, it requires a brief extension until June 20, 2018 to complete its review of these materials. AT Kearney is working diligently with the business team to review these materials in determining the extent of in camera treatment required. AT Kearney understands that Respondent may be designating some of these materials for *in camera* treatment as well, which should reduce duplication. AT Kearney's counsel notified counsel for both parties via telephone on June 8, 2018 that it would be filing a motion to

extend the deadline for seeking *in camera* treatment of confidential documents. Both Complaint Counsel and Respondent's Counsel indicated that they would not object to AT Kearney's motion for a brief extension.

For the reasons set forth above, AT Kearney respectfully requests an extension to file a Motion for in Camera Treatment until June 20, 2018.
