

SPEAKER BIOS

Dwain Alexander II, Capt. Ret. USN

Mr. Alexander is the senior supervisory civilian attorney and subject matter expert for the Region Legal Service Office, Mid Atlantic (RLSO) in Norfolk, Virginia. He earned his Bachelor of Science Degree and his Juris Doctor from Creighton University. After law school, he joined the Navy Judge Advocate General's Corps. Mr. Alexander left active duty in 1996 and affiliated with the Navy Reserves where he attained the rank of Captain prior to retiring in October of 2013.

At the RLSO, Mr. Alexander is responsible for legal assistance program development. He tracks and provides comments on both legislation and agency rules that impact legal assistance and drafts legislative proposals related to the legal assistance areas of practice. He provides legal services to servicemembers and their families, with his primary areas of practice being estate planning, consumer law, and family law, representing thousands of clients over his 24 years of service with the Navy. He mentors, trains, and contributes to the professional development of attorneys, enlisted and staff at the Navy's largest Region Legal Services Office.

Mr. Alexander is a frequent speaker at conferences and continuing legal education courses on the Servicemembers Civil Relief Act, automobile transactions and auto fraud, family law and servicemembers' rights. He has testified before the Senate Commerce Committee on "Consumer Issues Facing the Military." and before the Senate Judiciary Committee on "Access to Justice for Servicemembers." He is a contributing author for the National Consumer Law Center's publication on *Collection Actions* and the American Bar Associations publication, *Legal Guide for Military Families*. Mr. Alexander is the winner of two Distinguished Service Awards from the American Bar Association, the Department of the Navy Superior Service Award, and the National Image, Inc. Meritorious Service Award.

Michael Archer, Maj. Ret. USMC

Mr. Archer is the Director of Legal Assistance for Marine Corps Installations East, which is generally comprised of Marine Corps installations in the southeastern United States. His duties include supervision of military legal assistance attorneys, maintaining a preventative law and education program, and providing advice to eligible clients concerning civil matters, including consumer issues. He served for 20 years as a Marine Corps judge advocate, retiring from active duty February 2003.

While on active duty, Mr. Archer was assigned to various stateside and overseas positons, including chief of legal assistance in Okinawa, Japan; Camp Lejeune, North Carolina; and Yuma, Arizona. He has written numerous articles concerning military consumer and family law issues and is a frequent speaker on these topics. He has appeared before the U.S. Congress and, on multiple occasions, before the North Carolina General Assembly concerning military consumer issues. Mr. Archer has been a member of the North Carolina State Bar standing committee on Legal Assistance for Military Personnel (NC LAMP) since 1995. He is the recipient of both the NC State Bar and the American Bar Association Distinguished Service Award. He is the author of "Ripped Off: A Servicemember's Guide to Common Scams, Frauds, and Bad Deals," published in 2014 by the American Bar Association.

Nicholas Armstrong, Ph.D.

Dr. Armstrong is the senior director for research and evaluation at IVMF at Syracuse University where he leads IVMF's portfolio of applied research, policy analysis, and program evaluation efforts. He is also an affiliated adjunct public management faculty member in the Department of Public Administration and International Affairs at Syracuse University's Maxwell School. Before joining IVMF, Dr. Armstrong was a research fellow at Syracuse University's Institute for National Security and Counterterrorism where he led government and privately sponsored projects on topics including security sector reform, wartime contracting, post-conflict reconstruction, and community resilience.

Dr. Armstrong is a U.S. Army veteran of eight years with overseas deployments to Iraq, Afghanistan, and Bosnia as a Ranger-qualified artilleryman in the 10th Mountain Division. He is a graduate of the U.S. Military Academy at West Point (B.S.) and the Maxwell School of Citizenship and Public Affairs at Syracuse University (Ph.D., M.P.A.).

Josh Borderud

Mr. Borderud serves as Director of the Baylor University Law School Veterans Clinic. He earned his bachelor's degree in history, his master's degree in history, and his Juris Doctor—all from Baylor University. Following graduation, he worked as an assistant district attorney in Milam County, Texas, prosecuting criminal cases and serving as legal adviser to the county judge. He then joined the Waco law firm of Pakis, Giotes, Page & Burleson, P.C. as a civil litigator, representing individuals and businesses in a wide range of disputes. He has tried over twenty cases to jury verdict as lead counsel.

Mr. Borderud is a past president of the Waco-McLennan County Young Lawyers Association, a member of the Judge Abner V. McCall American Inn of Court, and a Fellow of the Texas Bar Foundation. Andrew Cohen, Col. Ret. USA

Mr. Cohen is the Acting Director, Office of Financial Readiness in the Office of the Deputy Assistant Secretary of Defense for Force Education and Training. He leads the Financial Readiness team in the planning, direction, control, and coordination of policies and programs to meet the financial literacy and preparedness needs of Service members and their families. Key programs in the Financial Readiness portfolio include financial literacy training, the Personal Financial Management and Counselor programs, the Military Lending Act, continued education of the force regarding the new Blended Retirement System, and assessing the financial literacy/preparedness of the force.

Prior to leading the Financial Readiness team, Mr. Cohen served nine years as Deputy Director of Finance and Treasurer for the Army Emergency Relief (AER), a private 501(c)(3) charity that provides millions of dollars a year in no-interest loans and grants to soldiers and their families to meet unexpected financial needs. His last duty assignment was as Chief, Resources Division for the Army's G-1. Mr. Cohen's military service covers 27 years as a commissioned officer in the U.S. Army, retiring with the rank of Colonel. Some of Mr. Cohen's other key assignments include serving as Comptroller for the 3rd Infantry Division, Director of Resource Management for Ft. Stewart, GA, and Defense Resource Manager on The Joint Staff.

Mr. Cohen holds a Bachelor of Science in Criminal Justice from the University of Cincinnati, a Master of Arts in Management from Webster University, and a Master of Science in National Resource Strategy from the Industrial College of the Armed Forces. His military and professional education includes the Command and General Staff College, Senior Service College and the Non-Profit Executive Management and Personal Financial Planning certificate programs at Georgetown University.

Anthony Davis

Mr. Davis is a Financial Counselor for the Military Family Readiness Center at Joint Base San Antonio Lackland (JBSA). He has been working at JBSA since November 2002, and now serves as one of two Team Lead Supervisors at the Military Family Readiness Center.

A native of Gary, Indiana, Mr. Davis graduated from Indiana University in 1976 with a BS in Business Administration. Upon graduation, Mr. Davis entered into the United States Army Corps of Engineers where he served as a Combat Engineer. He retired as a Major after serving for 23 years. After his career in the Military, Mr. Davis has worked in the Air Force branch of the Department of Defense. James Dingivan, Maj. USAFR

A native of San Antonio, Mr. Dingivan is an Assistant United States Attorney in the Western District of Texas—a district which encompasses one of the largest military communities in the United

He leads DOJ enforcement efforts to protect servicemembers' civilian employment rights by enforcing the Uniformed Services Employment and Reemployment Rights Act and promotes financial security for servicemembers, recent veterans, and military family members though the Servicemembers Civil Relief Act ("SCRA") actions brought on behalf of the United States. Mr. Dingivan also protects military voting rights by enforcing the Uniformed and Overseas Citizens Absentee Voting Act of 1986. Before joining the US Attorney's office, Mr. Dingivan spent nearly seven years in active duty as a member of the United States Air Force Judge Advocate General's Corps. While a member of the Air Force, then-Capt Dingivan first served as the Chief of Legal Assistance at the first and only tri-service Joint Base, leading an integrated Army and Air Force legal assistance team responsible for providing legal services to the New Jersey military and veteran community. He went on to serve as a prosecutor at the United States Air Force Academy in Colorado Springs, Colorado and as the Officer-in-Charge of the Area Defense Counsel's office at Joint Base San Antonio-Lackland, Texas. Mr. Dingivan is a Major in the Air Force Reserve and an Assistant Staff Judge Advocate at the 67th Cyberspace Wing. He received his JD from Emory University School of Law and his BA from Wake Forest University.

Bob Elder

After 30 years in journalism, Mr. Elder joined the Texas State Securities Board as the Communications and Investor Education Director in 2008 to work on investor education initiatives and expand the Agency's public outreach. He started the Agency's digital distribution service, which has nearly 15,000 subscribers, and oversees website content. He writes the State Securities Board's news releases and investor education content, both online and in print. Mr. Elder is the primary writer of the State Securities Board's *Texas Investor Guide: Investing Wisely and Avoiding Financial Fraud.* He also speaks regularly to civic groups, including public-sector employees, senior organizations, teachers, military personnel, and college classes.

Mr. Elliott has been an attorney in the Federal Trade Commission's Southwest Region since joining the FTC in 1988. Prior to joining TLSC, he practiced mass tort, insurance defense, and creditors' rights litigation at law firms in Houston, Dallas, and Maryland. Mr. Gillman is the Founder and CEO of Omniangle Technologies, a cyber intelligence firm providing actionable user experience reporting to Fortune 500 companies and to the financial sector. The task force resulted in multi-million dollar settlements with AT&T, Verizon Wireless, mQube, World Avenue, and Media Breakaway among others. Prior to joining the Commission, she was a partner at Wilkinson Barker Knauer, LLP, where she focused on FTC issues, including privacy, data protection, and cybersecurity. She was also Deputy Director of that office. From 1998 to 2001, she was an attorney advisor for former FTC Commissioner Orson Swindle, advising him on competition and consumer protection matters. She has authored a variety of articles on competition law, privacy, and technology matters.

Steven Robinson

Mr. Robinson is an Assistant Attorney General and the Managing Attorney of the San Antonio Regional Office of Texas Attorney General's Consumer Protection Division. Prior to joining the office in San Antonio, he worked in the Dallas office of the Consumer Protection Division. His recent cases and investigations have included diploma mills, unlicensed nursing schools, motor vehicle financing companies, false health claims by a diet supplement company, and enforcement actions against assisted living facilities. His interest in military consumer protection began with his personal experience clerking in the JAG office at Barksdale Air Force Base, where he saw the unique consumer challenges facing military service members. He holds a law degree from Loyola University New Orleans School of Law and an undergraduate degree from Mississippi College.

Olha N. M. Rybakoff

Ms. Rybakoff serves as Senior Counsel in the Tennessee Attorney General's Public Interest Division where she handles consumer protection and false claims enforcement litigation. W. G. "Bud" Schneeweis, Capt. Ret. USCG

Mr. Schneeweis has been the Associate Director of the Military Financial Readiness Project at the FINRA Investor Education Foundation since 2013. He spent a career in the U. S. Coast Guard, retiring as Captain. Following military retirement, he served on the staff of the Military Officers Association of America (MOAA), directing its Benefits Information and Financial Education Department

Mr. Thompson is the Owner and President of T.L. Thompson & Associates, Inc., a Dallas, Texas based agency started by his father in 1976. He enlisted in the U.S. Navy in 1976 and was trained as an Operations Specialist (Radar Operator). After transferring to the Naval Reserve in 1989, Mr. Thompson was recalled to Active Duty for Operation Desert Storm in 1991, eventually retiring as a Chief Petty Officer in 2000.

Upon returning home in 1992, Mr. Thompson entered the family business and joined his two brothers as a Collector, later becoming the Training Manager, then Collection Manager, and eventually General Manager. Becoming active in his state organization, Mr. Thompson served as President of the American Collectors Association (ACA) of Texas in 2000—the very same year he was honored as the ACA Instructor of the Year. The experience of having been deployed overseas in combat zones, coupled with his knowledge as an ACA Instructor, has given Mr. Thompson a unique insight into the challenges facing all armed forces members, and the ability to effectively train collectors on how to treat service members with the dignity and respect that they have earned.

David Winfrey

Mr. Winfrey serves as Financial Counselor at the Soldier and Family Assistance Center (SFAC) for the Soldier for Life Program at Fort Sam Houston. At the SFAC, he works with soldiers and their families, helping them successfully transition from the military into civilian life with financial security. Mr. Winfrey's experience ranges from coordinating Hiring Heroes Job Fairs to auditing the Oklahoma State Veterans Entrepreneurs program to better understand the challenges and opportunities for Wounded Warriors starting a business.
